The District does not encourage any student to transport other students in his/her vehicle or for students to ride with a student driver in a privately owned vehicle.

I acknowledge I have reviewed the following:

- 1) The Culver School District will not allow or encourage any student drivers to transport other students in privately owned vehicles.
- 2) It is the responsibility of the parent or guardian to arrange, provide or supervise transportation of their student.
- 3) The parent/guardian is responsible for verifying that personally owned vehicles used to transport their student are covered by statutory liability insurance, including underinsured motorist coverage, and that drivers transporting their student possess a valid driver's license.

District will not provide transportation, and recognizing the dangers and hazards inherent in participating in the above mentioned activities and any related transportation to and from activity events, to the fullest extent allowed by law, **on behalf of myself and my minor child**, I hereby voluntarily **agree to waive and discharge any and all claims of whatever nature and release from liability**, fully and finally, for myself, my child, our estates, our heirs, our administrators, our executors, our assignees, our successors, and to release, exonerate, discharge and **Hold Harmless** Culver School District, its Board of Directors, the individual members thereof, and all officers, agents, employees, volunteers, and representatives from any and all liability, claims, causes of action, or demands including attorneys fees, arising out of any injuries of any kind, whether physical or emotional, to me, my child, or to our property, or losses of any kind which may result from or in connection with my child's participation in the above listed activity up to and including injuries stemming from actions of the District or its employees or agents. I further certify and represent that I have the legal authority to waive, discharge, release, and hold harmless the released parties on behalf of my child.

This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.

PROOF OF PRIVATE VEHICLE LIABILITY INSURANCE

The following requirements according to EEAE-AR must be met for transportation of students in private vehicles:

PARENT/GUARDIAN

1. Students will be transported in private vehicles only for school activities.
2. Drivers must be at least 18 years of age.
3. Drivers must be properly licensed to drive:
4. Drivers must provide proof of valid vehicle liability insurance meeting or exceeding the minimum requirements as established by the state of Oregon and/or the district. Drivers acknowledge that in the event of an accident, the vehicle's insurance will provide primary coverage:
5. The vehicle must contain an adequate number of seat restraints, including when applicable, a child safety system for a child who weighs less than 40 pounds, regardless of age. The child safety system must elevate the person so that a safety belt or safety harness properly fits the individual and meets the minimum standards and specifications of law. A person over 40 pounds or who has reached the upper weight limit for the forward-facing car seat must use a booster seat until four feet nine inches or age eight and the adult belt properly fits. A person who is taller than four feet nine inches or eight years of age or older must be properly secured with a safety belt or harness that meets the requirements under Oregon Revised Statute (ORS) 815.055. Training in the proper installation and use of child safety systems may be required. It is recommended that students 12 years of age or younger do not ride in the front seat. The driver must require all students use safety restraint systems at all times when transported in the vehicle.
