## **Outdoor Contact Sports Opt-In Form**

This form is to be used by a school located in a county designated as High Risk or Extreme Risk to notify of its intent to opt in to offer outdoor contact sports for the 2020-21 school year in accordance with the Governor’s February 10, 2021 update to [Outdoor Contact Sports Guidance](#). Once final, this form will be posted to a school or district website and a link to it will then be sent to ODE.

*In Lower Risk and Moderate Risk counties, practices and games for outdoor contact sports, including high school football, can resume following health and safety guidance to be issued by the Oregon Health Authority.*

*In High Risk and Extreme Risk counties, where COVID-19 remains more widespread, schools and other sports organizations can opt-in to resuming outdoor full contact sports with additional protocols in place. In such counties, sports organizations must offer on-site responsive testing for symptomatic individuals and close contacts, contact information for contact tracing, and a waiver identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19. Schools in Extreme and High Risk counties must also have at least limited in-person instruction occurring, with the goal of achieving hybrid or full in-person instruction for students this school year. Schools must also be in compliance with state guidance for COVID-19 testing.*

### Plan Details for School Instructional Model

We have been back in-person since January 19th, 2021. We have 195 of our 207 students back on campus in two divided cohorts split between 9th/10th grade students in one group of 100 and 11th/12th grade students divided in another group. We have even split our cohorts at lunch so we are not crossing students with others to keep our staff and students safe. We require students to wash their hands before they enter the building multiple times a day, there is hand sanitizer in each classroom and masks are required by every person in the building, we also take each students temperature before they enter the classroom and document the information.

COVID TESTING IN CULVER SCHOOL DISTRICT

February 2021

Beginning March 1st Culver School district will be mandated to have COVID testing available in school if we are open outside of the metrics designed by the Oregon Department of Education. The purpose of the test is to provide access to testing to students that wouldn’t otherwise have the opportunity and to prevent any further outbreak

This program is intended to test ONLY symptomatic and exposed students and school staff.

The Abbot Binax NOW-COVID-19 Antigen tests are available for students and staff that become symptomatic with COVID symptoms while at school or have been exposed at school, if directed by Local

Health Authority. The testing accuracy is 64.2% when a person is experiencing symptoms and 35.8% if experiencing no symptoms. The test is a nasal swab that has to be self-administered with guidance by trained staff. The Abbot Binax Now test is a rapid (15) minute test.

We are required to obtain parent and student consent before we test. If a student or staff test negative and they have symptoms, they will still be required to leave and not return following the Ready School Safe Learners guidelines. Students or staff that become ill at home will not be allowed to come to the school to be tested. They will be referred to their doctor. If a test is positive, it will be reported to the Local Health Authority and will be counted as a positive case for the County.
